TERMS AND CONDITIONS

1. The following limitations apply to these fundraising tickets:
 - (a) Tickets valid for all public ordinary sessions scheduled prior to the expiry date. Not valid for special events or movie marathons. Cannot be used with any other offer.
 - (b) Tickets may be used by any patron over the age of 3 years
2. Redemption for admission to any particular cinema, movie or session is subject to seat availability.
3. Movie vouchers cannot be redeemed for cash, must not be on-sold without the written permission of Majestic Cinemas, are not refundable and are not available for exchange, unless required by law.
4. Movie tickets are made available subject to classification of the relevant film given by the Attorney Generals Department under the National Classification Scheme.
5. Majestic Cinemas Fundraising is open to schools and non-profit organisations only ("Fundraisers"). Fundraisers may distribute Family Order forms to members, collate Family Order forms and submit the Fundraiser Order form to Majestic Cinemas. Movie vouchers are sold at discounted pricing to permit fundraising. Therefore, for-profit organisations and companies are not permitted to purchase movie vouchers at fundraising prices. Should Majestic Cinemas suspect that a for-profit organisation or company has purchased through the fundraising scheme, Majestic Cinemas may at its discretion refuse to fulfill the relevant Fundraiser or Family Order. The Fundraiser agrees to cooperate with Majestic Cinemas and provide information regarding Family Orders received in any investigation in this regard.
6. Candybar vouchers must be redeemed in one transaction.
7. Each Fundraiser that purchases over \$5,000 worth of movie vouchers (at Fundraiser purchase prices) will receive 10 additional Movie Tickets ("Prize"). The Prize must be distributed by the Fundraiser to the member Family that purchases the most movie vouchers by dollar value. The Fundraiser agrees to distribute the Prize in this manner and will be liable to Majestic Cinemas in respect of any claims arising from any failure to do so.
